1. Introduction

2.2 Automatically Collected Information

• IP address, browser type and version

- Device identifiers
- Log data and usage patterns
- Location data (if enabled)

2.3 Competition Data

- Dancer and team names
- Competition results, scores, and rankings
- Audio-visual recordings and photographs (if applicable)

3. Legal Bases for Processing (GDPR Only)

Under GDPR, we process your personal data using the following legal bases:

- Consent Where you have given explicit consent for a specific purpose
- Contractual Necessity To perform a contract or pre-contractual measures
- Legal Obligation To comply with applicable laws and regulations
- Legitimate Interests For purposes such as improving services, securing our systems, or communicating with you

4. How We Use Your Information

We use your personal data for the following purposes:

- Providing and operating our software and services
- Managing competition entries and participant data

- Processing payments and invoices
- Sending relevant service communications
- Enhancing and securing our Services
- Fulfilling our legal and contractual obligations

5. Sharing Your Information

We do not sell your personal data. We may share it with:

- Service providers (IT, hosting, payment processing)
- Event organisers or adjudicators (for competitions)
- Legal authorities, if required by law

All third parties are required to comply with relevant data protection obligations, including under POPIA and GDPR.

If data is transferred outside of South Africa or the EU, we ensure it is protected using:

- Adequacy decisions
- Standard Contractual Clauses (SCCs)
- Other legal safeguards approved by the GDPR

6. Data Subject Rights

You have the right to:

- Access your personal data
- Correct or update inaccurate information

- Request deletion ("right to be forgotten")
- Object to or restrict processing
- Data portability (for EU/UK users)
- Withdraw consent where processing is based on consent
- Lodge a complaint with your local data protection authority

10. Children's Privacy

Our Services are not directed at children under the age of 18. Personal information of minors will only be processed with parental or guardian consent during competition events.

11. International Data Transfers

If we transfer your data internationally (e.g., to cloud hosting providers), we ensure that:

- Transfers are lawful under POPIA and GDPR
- Data is protected via contracts and/or data transfer mechanisms
